#### **Qlik NPrinting February 2019 and FIPS**

- This brief will describe how to successfully implement Qlik NPrinting February 2019 in an environment with the Federal Information Processing Standards (FIPS) security policy enabled.
- This workaround allows you to install and run Qlik NPrinting February 2019 (or later) on a Windows installation that has FIPS compliance policies in place.

#### What is the FIPS Security policy in Windows?

 The FIPS security policy in Windows forces the use of only FIPS-validated (FIPS 140) cryptographic algorithms. Both by disabling cipher suites available to the OS and by restricting algorithms available to Windows frameworks like .NET.

# Why does the FIPS security policy interact with Qlik NPrinting February 2019?

- When the FIPS security policy is enabled, Qlik NPrinting will work in a FIPS-enabled environment, even if the .NET libraries used are not FIPS compliant.
- Qlik NPrinting February 2019 uses non-approved algorithms for non-cryptographic operations, for example, the encoding of a PDF file.

## Should you run Qlik NPrinting February in an environment with FIPS?

- The answer to this question is yes, if FIPS is required. Qlik NPrinting February 2019 can operate in an environment where FIPS is enabled, albeit requiring additional configuration.
- The key question for an administrator of a Qlik NPrinting February 2019 site is whether FIPS is
  required due to regulatory or compliance factors for the organization. If FIPS is not required, then it
  is recommended to turn off FIPS due to the complexity of vigilance needed to configure Qlik
  NPrinting February 2019 to operate in a FIPS environment. If FIPS is required, then continue
  reading for guidance on how to successfully configure Qlik NPrinting February 2019 to interact with
  FIPS.

# Initial configuration of Qlik NPrinting February 2019

- This section will outline what additional configuration is required to successfully install, license, and configure Qlik NPrinting February 2019 (or later) in a FIPS environment. Qlik NPrinting February 2019 and other dependencies will always check if FIPS in enabled. To skip this, you need to edit several config files.
- The Server configuration must be performed on the designated server machine, and the Engine configuration must be performed on any designated engine machines.

## Server configuration

- 1. Install Qlik NPrinting February 2019 Server on the designated server machine.
- 2. Stop the Qlik NPrinting Scheduler and Qlik NPrinting WebEngine services (if running).
- 3. Right-click the Scheduler configuration file, and select Run as Administrator. The default location is:

%ProgramFiles%\NPrintingServer\NPrinting\Scheduler\Qlik.NPrinting.Scheduler.exe.config

4. Add the line <enforceFIPSPolicy enabled="false" /> to the <runtime> section.

- 5. Save the changes.
- 6. Right-click the WebEngine configuration file, and select Run as Administrator. The default location is:

%ProgramFiles%\NPrintingServer\NPrinting\WebEngine\Qlik.NPrinting.WebEngine.exe.config

7. Add the line <enforceFIPSPolicy enabled="false" /> to the <runtime> section.

8. Save the changes.

9. Restart the Qlik NPrinting Scheduler and WebEngine services and validate that they work as expected.

### Engine configuration

- 1. Install Qlik NPrinting February 2019 Engine on each of the designated engine machines.
- 2. Stop the Qlik NPrinting Engine service (if running).
- 3. Right-click the Engine configuration file, and select Run as Administrator. The default location is: %ProgramFiles%\NPrintingServer\NPrinting\Engine\Qlik.NPrinting.Engine.exe.config
- 4. Add the line <enforceFIPSPolicy enabled="false" /> to the <runtime> section.

- 5. Save the changes.
- 6. Restart Qlik NPrinting Engine service.

#### Upgrade process

 The process for upgrading Qlik NPrinting to a different version is the same as the initial setup process. Do note that the changes to the config files which were made initially to the Qlik NPrinting Server and Qlik NPrinting Engine services may be removed so an administrator will need to repeat the changes to the .config files for those services.
